



Auction Operations Status

Sale schedule status subject to change pursuant to government directive and labor availability.

- **All ADESA auctions now offer vehicles for sale via ADESA Simulcast and DealerBlock**, and are eligible for Simulcast+.
- **All ADESA auctions continue to follow CDC/PHAC guidelines on social distancing as well as any government-mandated public health and safety requirements.** Facial coverings or masks are required for visitors.
- **Dealers are permitted on site for buyer vehicle previews where offered.** Customers are required to bring and wear their own facial coverings, and submit a health status acknowledgment. Contact the local auction for additional details.
- **Redemptions are available by appointment only** and require a 30-minute call-ahead confirmation.
- **PSIs are available at all locations though services may be limited in Quebec and Ontario**; contact the auction for details.
- **Vehicles will be released with pre-printed or digital gate pass** at all locations.
- **All locations can receive inbound vehicles.**
- **All locations can receive and send titles/ownerships** via mail or dropbox.
- **Contact the local auction for information about all other transactional activities**— including payments, title/ownership processing and arbitrations.
